### New funding opportunity announcement Tribal Opioid Response

In case you haven't seen this new funding opportunity announcement (FOA) from the Substance Abuse and Mental Health Services Administration (SAMHSA) - see

the Tribal Opioid Response (TOR) grant below.

The objective is "to address the opioid crisis in tribal communities by increasing access to culturally appropriate and evidence-based treatment, including medication-assisted treatment (MAT) using one of the three FDA-approved medications for the treatment of opioid use disorder (OUD). The intent is to reduce unmet treatment need and opioid overdose related deaths through the provision of prevention, treatment and/or recovery activities for OUD." The funding is \$50 million over two years and they anticipate funding 263 awardees.

## Opioid Prevention Work in St. Louis County: Prevention and Intervention Strategies

St. Louis County Public Health and Human Services recently rolled out Minnesota Department of Health's Statewide Health Improvement Partnership (SHIP) Opioid Prevention Pilot Project. This work will focus on rural/northern St. Louis County and involve a tiered prevention strategy that aims primarily at reducing exposure to and abuse of opioids. Full story here...

#### **New Smoke-free Rule Protects**

### **Minnesotans in Public Housing**

Starting July 31, the federal Department of Housing and Urban Development (HUD) requires all public housing properties to have a smoke-free policy. The rule is a significant step to protect the health of residents, staff, and visitors from secondhand smoke, reduce fire risk and maintenance costs and provide cleaner and safer air.
