The MN Department of Human Services (DHS), Alcohol and Drug Abuse Division in partnership with the Association for Nonsmokers-MN is once again offering an educational tobacco compliance check opportunity (Congratulate and Educate) to enforcement agencies, public health or law enforcement, in Minnesota. The goal is to educate retailers about the important role they play in keeping Minnesota youth tobacco-free. Departments are reimbursed \$50 per vendor/per educational compliance check. All compliance checks need to be completed by June 30, 2019.


