

Community Health Needs Assessment Focus Groups

Every 3 years, North Memorial Health conducts a Community Health Needs Assessment to determine health priorities. In 2016, and after the data was reviewed, substance abuse was identified as a top health priority. If substance abuse is identified as a health priority during this year's assessment, it will help create a strong case for continuing substance abuse prevention efforts at the community level.
